- Ensure that all Livingston FC Women's players adhere to the Players Codes of Conduct and always maintain a high degree of discipline and professionalism.
- Collaborate with the Head of Player Recruitment and coaching staff to identify and recruit players into the women's team, aligned to Livingston FC's recruitment strategy.
- Liaise with Livingston FC Girls Academy Coaches to help create opportunities and smooth transition on the pathway from elite youth football to the Women's 1st Team.
- Build effective and positive working relationships with the support staff team including analysts, S&C coaches, sports therapists and physios.
- Liaise with the Medical Team to ensure there are adequate medical and welfare facilities available for players.
- To fulfil media obligations, public relations activities and events as required and represent Livingston FC in a professional manner.
- Attend Livingston FC Board meetings, where applicable, to contribute and provide updates on Women's Team matters.
- Observe, and be subject to, the rules, regulations, articles and by-laws of the Scottish Football Association, or any other relevant football governing body.
- Be responsible for personal continuous professional development and ensure qualifications are up to date.
- Observe Livingston FC Safeguarding, Equality and Diversity, and Health and Safety policies and undertake training as required.
